Process Overview

- The Superintendent and the Federal programs department worked together to identify ESSER III planning Committees with all required Stakeholders. The committee members were assembled and given assigned areas of consideration to evaluate. Prioritized Strategies

- Authorized under the Elementary and Secondary Education Act (ESEA) and The Individuals with Disabilities Act (IDEA)
- Coordination of preparedness and response efforts to prevent, prepare for and respond to coronavirus
- Activities to address the unique needs of low-income students, students with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and foster care youth
- Developing and implementing procedures and systems to improve the preparedness and response efforts of the district.
- Supplies to sanitize and clean District Facilities



Prioritized Strategies

- Planning for, coordinating and implementing activities during long-term closures, including providing meals to eligible students (includes pre-award)
- Planning for, coordinating and implementing activities during long-term closures, including technology for online learning to all students
- Planning for, coordinating and implementing activities during long-term closures, including how to ensure other educational services can continue to be provided consistent with all Federal, State and local requirements
- Purchasing educational technology for students that aids in regular/substantive educational interaction between students and instructors, including low-income students and SWD, which may include assistive technology or adaptive equipment



Prioritized Strategies

- Providing mental health services and supports, including through implementation of evidence based full-service community schools
- Planning and implementing activities related to summer learning
- Planning and implementing activities related to supplemental afterschool programs or online learning
- Other activities deemed necessary to maintain the operation of and continuity of services including continuing to employee existing staff
