A quorum of members of the Central School Board Region will participate in the meeting and will be audible to the public.


Items will not necessarily be discussed or considered in the order they are printed on the agenda below.

The Texas Open Meetings Law prohibits the Board from taking action on any item not on the official agenda. Citizens wishing to speak to the Board must register prior to the start of the meeting. Three minutes per person are allowed for presentations. Written statements may also be provided. The time limit is necessary to provide citizens an opportunity to give input while allowing adequate time for Board business.
